## Affiliate with Department of HealthCare Services (DHCS)

The MMCP Entity must be contracted with DHCS to provide health care services to enrolled Medi-Cal beneficiaries. Click [here](#) to access the MMCP Health Plan Directory webpage to verify if you are enrolled with DHCS.

## Application and Onboarding

The MMCP Entity Primary Contact must access and complete all required fields of the application within the Enroller Portal self-registration page at: <https://covered-ca.my.site.com/enrollerportal/s/launch-application>

- At least one counselor must complete the Certification process prior to the Entity becoming certified.
- Submit the application

## Application Review by Covered California

Covered California reviews the newly submitted Entity application for initial eligibility (this process can take 3 business days) and will reach out to the MMCP Entity to obtain missing information once it has been determined you are eligible to continue the application process.

If eligible, Covered California will send an access code to continue with the application process, which includes designating a Primary Contact, Authorized Contact, and the first eligible counselor to complete the certification process.

**Important:** Please designate a counselor that will be able to complete the process within the 30-day time limit.

- Entity Agreement (DocuSign)
- Proof of:
  - Current business license
  - Insurance coverage (general liability and workers' compensation.) Ensure Covered CA (1601 Exposition Blvd, Sacramento, CA 95815) is listed as a Certificate Holder.
- Conflict of Interest Prevention Plan
- W-9 (for Entity)

## Entity Management Training

Covered California emails instructions to the MMCP Entity Primary Contact to complete the required online Entity Management Training in the Learning Management System (LMS) within 30 days from registration. This is a 30-minute training and does not have an exam requirement.

## Register in Enroller Portal ([coveredca.com](https://coveredca.com))

After an MMCP Entity applicant meets all registration requirements, the following must be completed:

- Primary Contact, Authorized Contact, and Counselor will receive two (2) emails: one with an Access Code to create a username to gain entry to their dashboards to begin assisting consumers. Another email with the [link to enter the Access Code](#) and further instructions.
- Once username is created, log in to the [Enroller Portal](https://covereca.com) (covereca.com)
- Complete the Security Questions and update email address and cell phone number for password recovery.
- Upon completion of all registration requirements, the Certified Entity may now add additional enrollment counselors to their roster and begin to assist consumers in enrolling in affordable health care insurance.
